Contents

Definition of the object of study: elaboration of the Master's Thesis and follow-up with the tutor.

Once the topic of study and research has been chosen, the student will prepare his/her Final Master's Thesis individually, following a series of guidelines and indications offered by the tutor. The sessions of assessment and revision of the work will be agreed upon, according to the academic calendar.

Learning System and Methodology / Contingency Plan

ACTIVITIES AND METHODOLOGY

Individual work: Information research, reading sessions, analysis and study of the problem, writing.

Follow-up meetings/tutorials with the advisor.

CONTINGENCY PLAN:

The research work, elaboration and writing of the Master's Thesis is associated with activities that the student develops individually: bibliographic search, bibliographic search, collection of information, analysis and study of the problem, writing of the work.
