### Criteria and Assessment Tools / Contingency Plan

For this, the following criteria will be taken into account:

## Ordinary call:

Continuous Assessment System:

- b) Final exam testing the contents of the course. This exam will compute 60% on the final grade for students who have participated in the continuous assessment tests

Single final assessment: Final exam testing the contents of the course. This exam will compute 100% on the final grade

### Extraordinary call:

Single final assessment: Final exam testing the contents of the course. This exam will compute 100% on the final grade

#### Contingency plan

It will remain as described in the evaluation section. In cases where the health authorities advise and/or agree on the non-attendance of the evaluation tests in the ordinary and/or extraordinary calls, the indicated tests will be carried out through the virtual Blackboard Learning platform ".
