#### **Content Justification**

The students of the itinerary 2 of the Master will carry out obligatory professional practices in institutions and organizations both external and from the University of Almeria, supervised by professionals and academics. The internship will be equivalent to 12 ECTS credits, that is, around 300 hours of work that the student will distribute between preparation and work in the field of professional performance that is assigned according to the academic profile of the students.

## Contents

**Training Project** 

1) The main objective of these practices is to offer the student the necessary mechanisms and processes that will allow him/her to apply and complement the knowledge and skills acquired in their academic training, promoting the acquisition of competencies that prepare him for the exercise of professional activities, facilitate his employability and promote his capacity; through immersion in the work, professional and business activity of the sector.

2) Each practice has associated specific activities to be performed by the student that are defined by the company and the coordinator, within the general framework of the educational objectives included in the study program. Among others, some specific activities may be:

- Teaching the English language in educational centres at different levels

- Oral and written translation and interpretation

- Conservation and cataloguing of cultural property

- Activities to disseminate the heritage

- Participation in literacy campaigns and academic support in subjects related to different groups at risk of social exclusion.

- Academic participation in groups and research projects

- Elaboration of material related to communication: magazines, radio, televisión

3) The student will fulfil the internship in a work centre that offers a professional experience related to some of the career opportunities of the academic profiles. Educational centres, private companies, language schools, trade and international relations companies, museums and monuments.

4) For the realization of the external practices the students will have a tutor of the collaborating entity and a tutor at university. The tutor of the collaborating entity will be a person linked to the same, with professional experience and with the necessary knowledge to perform an effective guardianship. The academic tutor will be a professor of the university, the coordinator of the master program. Tutorials are a fundamental element of the external practices and tutors, both from the university and the collaborating companies, are a key part of its development.

5) According to a standardized model established by the university, the tutor of the collaborating entity will make a final report to assess the student's activity during the internship. This professional report will

collect the number of hours carried out by the student and the evaluation of both the generic and specific competences included in the study program. The academic tutor will be the one to evaluate the internship based on the monitoring carried out, the report of the external tutor and the student's final report. For curricular practices, the signature of the official qualification certificate corresponds to the person in charge of practices designated by the center or, if applicable, the person responsible for the corresponding subject.

FINAL REPORT: The student will make and send to the academic tutor of the university, through the corresponding computer application (ICARO), the final internship report, according to a standardized model (extensión: min 5-max.10 pages), which should include, among others, the following aspects

a) Personal data of the student.

b) Collaborating entity where the internship has been carried out and place of location

c) Specific and detailed description of the tasks, work carried out and departments of the entity to which he has been assigned.

d) Assessment of the tasks carried out with the knowledge and skills acquired in relation to the study program.

e) List of the problems raised and the procedure followed for their resolution.

f) Identification of the contributions that, in terms of learning, the practices have made.

g) Evaluation of the practices and suggestions for improvement.
